## Non Repellent Formulation - Undetectable Technology.

The key feature and unique physical property of SAS PRO is that it is undetectable to ants. This means they do not avoid the treated areas and will pick up the insecticide on their bodies without even realising it.

Strategically in an ant management program, the use of non-repellent formulation technology is important to avoid issues related to insecticide avoidance as well as being able to distribute insecticide to greater insect population for colony eradication.



## Cutting Edge Chemistry.

SAS PRO has SmartKill Technology® which means that the product not only controls ants coming into contact with it, but will also be transferred to the Queen and workers resulting in total nest destruction.

This is particularly important for the control of ants as it is through their social interaction that the potent active can distribute throughout the colony to have maximum effect.

SAS PRO utilises the effectiveness of fipronil in its granular delivery mechanism to introduce a lethal dose into a colony situation leading to total colony control. However, this process is not instantaneous which means SAS PRO will not cause an accumulation of dead ants immediately. Instead, ants continue to behave normally and go about their regular routines for a short time before dying.

This delayed mortality is an important feature as it ensures ant colonies gain maximum exposure to the treated areas thus improving efficacy.
